Scope:

Expansion and replacement of existing residence facilities was anticipated in the 2012 Campus Master Plan. Construction of the new Residence Hall will allow the University to implement a third year requirement for on-campus housing. The planned 360-bed (student + RA beds), approximately 103k gsf, 4-story facility, will accommodate traditional-style double rooms for first year students, RA units, lounges and study spaces, a Resident Director apartment, a Priest or faculty apartment, and a small Chapel.

The sustainability target is LEED-Sliver.
