**RESOLUTION IN SUPPORT OF A PARK AT THE
SOUTHWEST CORNER OF RIGGS ROAD AND SOUTH DAKOTA AVE NE**

WHEREAS, the Council of the District of Columbia approved the Riggs Road and South Dakota Avenue Small Area Plan (SAP) on March 3, 2009, to develop a strategic plan and revitalization strategy for the area surrounding the intersection of Riggs Road and South Dakota Avenue NE; and

WHEREAS, one of the short-term goals of the SAP was the creation of a park at the southwest corner of Riggs Road and South Dakota Avenue NE; and

WHEREAS, in 2017, ANC 5A voted unanimously in support of the creation of the aforementioned park (ANC 5A Resolution Requesting Development Of A DPR-Managed Park On The Southwest Corner Of Riggs Road And South Dakota Ave., September 27, 2017); and

WHEREAS, the aforementioned SAP was fully incorporated into the 2021 DC Comprehensive Plan; and

THEREFORE, BE IT RESOLVED that ANC 5A strongly reiterates its previous support for the development of a DC Department of Parks and Recreation-managed park at the southwest corner of Riggs Road and South Dakota Ave NE; and

BE IT FURTHER RESOLVED that ANC 5A requests the District government regularly consult with ANC 5A, other nearby ANCs, and neighborhood groups in the vicinity of the greenspace in the development of the aforementioned park to ensure that community desires are reflected in the final designs.
