#### Holiday Trees and Greenery Collection Now Until March 2

The DC Department of Public Works (DPW) will collect holiday trees and greenery from January 3 through March 2 from DPW-serviced households, which includes single-family homes and apartment dwellings with three or fewer units. Here is what you need to know about this year's holiday tree and greenery collection:

- Trees and greenery collected during this time will be composted in support of DC's Zero Waste initiative.
- Holiday trees and greenery will be collected within 5 days of set out.
- Holiday trees and greenery will be collected from the front of the residence at the curb. For missed collections, residents can call 311 and make a "Christmas Tree Removal - Seasonal" service request from January 3 -March 2.
- All residents can also drop-off holiday trees and greenery at three locations, Monday through Friday, 8:00 a.m. – 4:00 p.m. beginning January 3:
  - 201 Bryant St. NW (Roll off box)
  - Guy Mason Recreation Center (3600 Calvert St NW)
  - 2700 South Capital St., SE (Roll off Box)

#### LRCA Meeting on Dec 4, 2023

**Treasurer's Repor**t: \$17,008.41 Beginning Balance \$346.45 Deposits \$709.05 Expenses (Printing and tech work), \$16,661.11 Ending Balance

Meeting called to order at 6:03 PM by Danielle Lewis-Wright at the Lillian Huff Lamond Riggs Library.

First-time attendees were welcomed to the meeting. Agenda shared and attendees are welcome to stay for refreshments and fellowship at the end of the meeting.

The first guests are **Mark Regulinski** from **Cafritz Foundation** with updates on the Arts Place at Fort Totten Development (<u>www.artplacedc.com</u>), assisted by Sean Cahill of Cafritz Enterprises and Alex Shield of H&R Retail who are leading the leasing team. While Phase I is moving along nicely there are still some spaces available. One Fitness in Phase I will be expanding its space as it has been wildly successful. Coming to Phase II are: Urban Brewery, Menomale (Neapolitan style) Italian Restaurant, an Ice Cream Shop, Potentially Pet Services/Daycare, Phoenix Hair Salon, as well as continuing work for Aldi to open in Phase II.

Phase II timeline includes Aldi's opening in Oct 2024, Children's Museum in 2025, and 294 rental units similar to Modern.

Approval of the minutes with a small edit that a local Public Safety Committee passed out literature regarding the DC Free Security Camera Program.

Also, DPW starts Section C of the leaf pickup, please checkout Snow.DC.Gov to be prepared for winter and sign up to assist your neighbors who may need help with snow removal, and check out DCHealthlink during this open enrollment period: Sign up by Dec. 15th for Jan 1st or by Jan 15th for a Feb 1st start coverage date. Work continues regarding the vendors outside of Walmart. While street vending was decriminalized and permits aren't required vendors but cannot harass pedestrians or block the sidewalk.
